

# 2020 Mannatech Makeover Money Challenge Canada and United States Mannatech Associates

**Promotion Period:** 

September 1, 2020 - November 30, 2020

**Extended time:** 

August 22 – 31, 2020

**United States and Canada only** 

With more and more people working from home, many have used this time to update their homes, backyards and home offices to make their living spaces more comfortable for both work and play. What would you add/change in your house, apartment, backyard if you could earn Makeover Money? Would you update your home office, your kitchen, add a television to your den, purchase a new toolbox and get organized? Or Would you order a new area rug for your family room, get new tile for your bathroom, add a deck or buy weight lifting equipment? Or maybe you just want a new toaster oven or a blender.

Each month during the Promotion Period Associates have the opportunity to earn Mannatech Makeover Money to use toward a gift card(s) from their favorite home improvement or home décor store, and earn Mannatech Makeover Points to earn a home Makeover as described below.

Here's how it works.

# 1) Gift cards/Makeover Money

For every new Associate and new Customer enrolled with an order of \$100 or more during the Promotion Period the enroller will receive 5% of the product order dollar value in Mannatech Makeover Money to use toward gift cards.

# 2) Mannatech Makeover Points / Big Makeover prizes

In addition, for every product order for which you earn Mannatech Makeover Money, the enroller will also receive Mannatech Makeover Money Points equal to the amount of the product order.

For example: for a new Associate or Customer product order during the Promotion Period of \$250, the enroller will receive 5% of the new order amount (in this case \$12.50) in gift cards and 250 Mannatech Makeover points order.

### **PPV Bonus**

New Associate is defined as an Associate enrolled from August 22 - November 30, 2020

The first month during the Promotion Period that a New Associate (see above) builds new PPV of 500 or more, the New Associate will earn an additional 5% in Makeover Money on the total PPV for that month. Once the New Associate builds the 500 PPV for a first month, the New Associate may continue to earn an additional 5% for each month thereafter that the new 500 PPV is maintained

during the Promotion Period. Please note that personal orders by the New Associate do not count toward the increase of 500 PPV for incentive purposes.

# For example:

New Associate (Jesse) enrolled August 27, 2020 (all PPV in this example being from other than the New Associate Jesse)

September PPV = 300 / no PPV bonus

October PPV = 550 / 5% in Mannatech Makeover money will be earned or an additional \$27.50 toward a gift card.

November PPV = 600 / 5% in Mannatech Makeover money will be earned or an additional \$30.00 toward a gift card.

## **PPV Bonus**

# Existing Associates are Associates enrolled prior to August 22, 2020

Existing Associates must increase their baseline by 500 points to earn the PPV Bonus as described above. Mannatech will use July 2020 PPV as the baseline amount. Please note that just like the rules for New Associates, personal orders of Existing Associates do not count toward the calculation of the increase of 500 PPV for incentive purposes.

# **Example:**

**Existing Associate Harry** 

July 2020 PPV baseline is 750

August PPV = 1000 / No Mannatech Makeover money earned

September PPV = 1300 / 5% in Mannatech Makeover money will be earned or an additional \$25 toward a gift card (this is because he exceeded his baseline PPV by 500 or more).

October = 1000 / No Mannatech Makeover money earned

November = 1500 / 5% in Mannatech Makeover Money will be earned or an additional \$37.50 toward a gift card.

#### **Enroller Makeover Bonus:**

The enroller will earn an additional 5% each month in Mannatech Makeover Money for each personally enrolled new Associate who achieves 500 PPV from new Customer product orders during the promotion period.

#### **Makeover Point Earners:**

The Top 10-Mannatech Makeover Point Earners at the end of the promotion period will earn additional prizes.

If there is a tie for points, the Associate with the highest number of new enrollments with a product order will win the tie.

Here's what you can earn.

- First Place \$10,000 makeover
- (1-winner)
- Second Place \$5,000 makeover
- (1-winner)
- Third place winners for a \$2,000 makeover (1-winners)
- Fourth place winners for a \$1,000 makeover

- (2-winners)
- Fifth place winners for a \$700 makeover
- (2-winners)
- Sixth place winners for a \$500 makeover
- (3-winners)

A minimum of 3000 Makeover Points is required to earn the First Place and Second Place.

Mannatech Makeover Money will be awarded at the conclusion of each month + 15 days. Mannatech Makeover point earners will be awarded at the end of the promotion period + 15 days.

Officers, directors, and/or employees or family members of Officers, directors and employees of Mannatech are ineligible for this promotion. This promotion is void outside of the United States and Canada and where prohibited by law. This promotion is not open to residents of Quebec. Transfer of qualification to another country or Associate is prohibited. Associates must have a valid address on file with Mannatech and only 2 winners may compete or be awarded per household/address.

Gift card earners will be notified via the email on record with Mannatech within 15 days of the end of each month. Makeover Point earners will be notified within 15 days of the end of the program or December 15, 2020.
